21	AFFECTED PORTIONS OF MUTCD: Section 2B.55, Table 2B-1, Figure 2B-3 (2009 MUTCD)

23	DISCUSSION:		
24			
25	The Synthesis of Signs conducted by FHWA also included a recommendation to include a Photo		
26	Enforcement sign.		
27 28	The current edition of the MUTCD does not have a sign that can be specifically used at a signalized		
20 29	intersection where Red Light Running (RLR) Cameras are in use. The TRAFFIC LAWS PHOTO ENFORCED		
29 30	sign is intended to be used at jurisdictional boundaries. When used in this fashion, it would normally be		
31	installed on all roadways entering the jurisdiction. Using this sign for a large municipality with many		
32	entering roadways would be cost prohibitive.		
33	······································		
34	The other options in the current MUTCD are the Photo Enforced (R10-19P) plaque or the PHOTO		
35	ENFORCED (R10-19aP) word message plaque. These plaques are intended to be mounted below existing		
36	regulatory signs. There are limited options of existing regulatory traffic signal signs below which these		
37	plaques could be mounted to convey this message. The STOP HERE ON RED (R10-6 or R10-6a) signs		
38	could be used but many jurisdictions only install the STOP HERE ON RED sign where there is a		
39	documented issue with motorists observing the proper stopping location and the sign is at the		
40	intersection which may be too late for drivers to be informed of the regulation.

42 The final option in the current MUTCD is to use the Photo Enforced (W16-10P) plaque or the PHOTO

43 ENFORCED (W16-10aP) word message plaque below a Signal Ahead (W3-3) sign. As Signal Ahead signs

44 are often only employed where there is a sight distance restriction, there are many intersections where45 these plaques can only be used if unwarranted Signal Ahead signs are installed.


As a result of this lack of an appropriate sign, many jurisdictions have developed a sign to be used for
this application. Examples of the various signs developed are as follows:

Missouri has requested interim approval for a new regulatory sign incorporating a new symbol for traffic signal photo enforcement based upon the completed official experimentation 2-595(E) MO New Symbol for Traffic Signal Photo Enforcement. This report found that the experimental sign with a signal head symbol was more correctly identified (79.6%) by survey participants than the standard word message sign with legend of "PHOTO ENFORCED" (75.1%). Missouri experimented with Sign 1 as shown above.

61 The RWSTC at its June 2010 meeting discussed the background color and voted in favor of the white 62 background as a "notice" regulatory sign. New Jersey, in conjunction with a five year pilot program for 63 RLR Cameras, opted for Sign 2 as shown above. Sign 2 is used in Maryland as well as NJ, Sign # 3 is 64 used in Phoenix, Arizona, Sign 4 is used in Washington, D.C, and Sign 5 is used in Hillsborough County, 65 Florida. The general feeling was that the additional text would assist motorists in understanding the 66 new program and generate fewer complaints from motorists who were cited. 67

82	Figure 2B-3) may be mounted below a regulatory sign to advise road users that the regulation is being	
83	enforced by photographic equipment.	
84	03 A Traffic Signal PHOTO ENFORCED Sign (R10-XX sign (see Figure 2B-3) may be installed in advance of	
85	or at a traffic signal to advise road users that signal compliance is being enforced by photographic
