
Figure 2F-6 Examples of Guide Signs for the Entrance to a Toll Highway on which Tolls are Collected Electronically Only

The toll committee task force requested that RWSTC and GMISTC evaluate the applicability of the yellow background and black copy "warning" color of the M4-15 "TOLL" sign shown in Figure 2F-4 given the auxiliary route sign number and designated use. Should the sign be considered a regulatory sign instead of warning? Should the sign number be warning instead of auxiliary route?

Section 2F.11 requires that the M4-15 plaque be mounted above route markers in all route sign assemblies **approaching** tolled highway segments to warn drivers that the segment of highway they are about to enter is tolled.

- Section 2F.13 further expands the use of the TOLL plaque requiring that a rectangular yellow background panel with black legend TOLL be incorporated into guide signs leading road users to a tolled highway or highway segment.
- Section 2C.01 states that warning signs call attention to unexpected conditions on or adjacent to a highway that may not be readily apparent to road users. Section 2C.03 states that unless specifically designated otherwise, all warning signs shall be diamondshaped with a black legend and border on a yellow background.

Section 2C.53 and Section 2C.54 states that supplemental warning plaques shall be used only in combination with a warning or regulatory sign they supplement.

Section 2D.12 requires that all route sign auxiliaries match the color of the route sign they supplement. Other M4-XX auxiliary route markers such as TRUCK, TEMPORARY, ALTERNATE, BUSINESS, JCT are consistently utilized in all route sign assemblies related to the applicable highway or highway segments including confirmatory route marker assemblies.

The yellow background with black copy "TOLL" auxiliary warning sign is used to call drivers attention to the tolled condition of a highway or highway segment to which they are being guided. The sign is to be used in route sign assemblies and on guide signs approaching tolled highways or highway segments but its use is independent of other regulatory and warning signs. Route sign continuity is not maintained as the warning sign is only required to be used on approach to the tolled highway or highway segment and its use in not required in confirmatory route marker sign assemblies., The "TOLL" auxiliary warning sign is not being used as a supplemental plaque nor as a route sign auxiliary.

RECOMMENDATION: Retain the yellow M4-15 plaque as shown in Figure 2F-4 below and Sections 2F.11 and 2F.13 noted below. Change the M4-15 designation to a W16-X code.


83 Section 2F.11 TOLL Auxiliary Sign (M4-15W16-X)

84 Standard:

- 85 on The TOLL (M4-15W16-X) auxiliary sign (see Figure 2F-4) shall have a black legend and border on a yellow background and shall be mounted directly above
- 87 the route sign of a numbered toll highway or, if used, above the cardinal

direction and alternative route auxiliary signs, in any route sign assembly providing directions from a non-toll highway to the toll highway or to a segment of a highway on which the payment of a toll is required.


- 95 of Toll plazas are used on many toll highways, bridges, and tunnels for collection of tolls from road users. Electronic toll collection and/or open-road tolling might also be used on such facilities, either in addition to or in place of collecting toll payments at toll plazas.
- 98 02 Chapter 2G contains information regarding signs for preferential and managed lanes that are applicable to toll roads.
- 100 03 Chapter 3E contains information regarding pavement markings for certain toll plaza applications.

102 Standard:

- 103 04 Directional assemblies for entrances to a toll highway or to a road leading directly to a toll highway with no opportunity to exit before paying or being charged a toll, shall clearly indicate that the facility is a toll facility. The TOLL
- $106 \quad (\frac{\text{M4}-15\text{W}16-\text{X}}{\text{M}})$ auxiliary sign (see <u>Section 2F.11</u>) shall be used above the route

- sign of a numbered toll facility in any route sign assembly that provides
- directions to the toll route from another highway.
- 109 05 A rectangular panel with the black legend TOLL on a yellow background shall
- be incorporated into the guide signs leading road users to a toll highway (see
- 111 **Figure 2F-5**).

- (see Chapter 2G) shall have white legends and borders on green backgrounds,
- except as specifically provided by <u>Sections 2F.13</u> through <u>2F.16</u>.

- the guide signs, as long as the proper legend and background colors are preserved.

129 <u>Figure 2F-5</u> Examples of Guide Signs for Entrances to Toll Highways or Ramps



- 139 11 If only vehicles with registered ETC accounts are allowed to use a toll
- highway, the guide signs for entrances to such facilities shall incorporate the
- pictograph adopted by the toll facility's ETC payment system and the regulatory
- message ONLY (see <u>Figures 2F-1</u>, <u>2F-5</u>, and <u>2F-6</u>). The use, size, and placement
- of the ETC pictograph shall comply with the provisions of Sections 2F.03 and
- 144 **2F.04**.

- highways that only accept ETC payments.
