34 DISCUSSION

There are some roadway conditions subject to warning signage such as DEAD END and NO OUTLET where it may be appropriate to expect the condition not apply to bicyclists. For example, the AASHTO *Guide for the Development of Bicycle Facilities* 2012 4th Edition notes that roadways which terminate as a dead end or cul-de-sac may serve as a continuous route for bicycle travel through the use of connecting paths or barrier openings, This plaque provides a simple and clear method for appropriately allowing these exceptions.
