DISCUSSION

Chapter 2I of the Manual on Uniform Traffic Control Devices provides for a category of guide signs known as General Service signs that are intended to provide road users with information signing for traveler services. It also states that general service signs may be used on any class of highway where an engineering study determines a need. This proposal adds D9 services signs to Chapter 9B of the MUTCD.
