### SUMMARY:

This proposal provides revised text and Figures for marking buffered bicycle lanes to replace the Figure in a proposal originally approved June 2014.

### DISCUSSION

FHWA has indicated that buffered bicycle lanes can be installed as buffer-separated preferential lanes as defined in Section 1A.13 and in accordance with the Standards and Guidance in Section 3B.24 and Section 3D.02. These lanes have been installed at numerous locations but the pavement marking patterns have not been uniform. The BTC developed a proposal for buffered bicycle lane markings including markings at driveways or minor commercial entrances where turns across the bicycle lane are permitted. The proposal was approved by Council on 6/28/14.

34 Since the approval of the proposal in 2014, experience with buffer installations has revealed  
35 constructability problems when installing chevron cross hatching markings in buffers narrower  
36 than 4 foot wide and diagonal markings in buffers narrower than 2 feet wide.

## 38 RECOMMENDED MUTCD CHANGES

39

40 The following present the proposed changes to the current MUTCD within the context of the  
41 current MUTCD language. Proposed additions to the MUTCD are shown in blue underline and  
42 proposed deletions from the MUTCD are shown in ~~red strikethrough~~. Changes previously  
43 approved by NCUTCD Council (but not yet adopted by FHWA) are shown in green double  
44 underline for additions and ~~green double strikethrough~~ for deletions. In some cases, background  
45 comments may be provided with the MUTCD text. These comments are indicated by  
46 highlighted light blue in brackets.

### 50 CHAPTER 1A. GENERAL

52 The following definition is added to Section 1A.13 of the MUTCD:

#### 54 Section 1A.13 – Definitions of Headings, Words, and Phrases in this Manual

##### 56 **Standard:**

57 xx. Buffered Bicycle Lane-a bicycle lane that is separated from the adjacent general-  
58 purpose lane or parking lane by a pattern of standard longitudinal markings. The buffer  
59 area might include chevron or diagonal markings. (Approved by NCUTCD Council 6/28/14)

## 61 PART 9. TRAFFIC CONTROL FOR BICYCLE FACILITIES

### 63 CHAPTER 9C. MARKINGS

64

65 A new Section 9C.xx is inserted into Part 9 of the MUTCD:

67 Section 9C.xx. Buffered Bicycle Lanes (Approved by NCUTCD Council 6/28/14)

##### 68 Support:

69 01 Pavement markings can designate a buffer area between a bicycle lane and adjacent general  
70 purpose lane and/or parking lane. A buffer area provides a greater separation between the bicycle  
71 lane and adjacent lanes than is provided by a single normal or wide lane line.

##### 72 Option:

73 02 A bicycle lane buffer area may be used to separate a bicycle lane from an adjacent general-  
74 purpose lane and/or parking lane.

##### 75 **Standard**

76 ~~03 If used, a buffer between a bicycle lane and general-purpose lane or parking lane shall~~  
77 ~~be delineated by standard normal width longitudinal pavement markings.~~ [Approved by  
78 NCUTCD Council 6/28/14 Attachment No.28]

80 Guidance:  
81 03 If used, a buffer between a bicycle lane and general purpose lane or parking lane should be  
82 delineated by normal width longitudinal pavement markings.  
83 ~~04— Consideration should be given to installing chevron or diagonal markings as appropriate in~~  
84 ~~a bicycle lane buffer area. The use of chevron or diagonal markings in a bicycle lane buffer~~  
85 ~~area should be based on engineering judgment and the Standards and Guidance in Section 3B.~~  
86 ~~24 and Figure 9C-x.~~ **[Approved by NCUTCD Council 6/28/14 Attachment No.28]**  
87 Option:  
88 04 Chevron markings or diagonal markings may be installed in a bicycle lane buffer area based  
89 on engineering judgment.  
90 05 Where a bicycle lane buffer is marked, the chevron or diagonal markings may be omitted if  
91 the gap between the longitudinal lines of the buffer area is less than 2 feet wide.
